ORDINANCE NO. 2 OF 2019 DISPLAY OF "911" PHYSICAL ADDRESS ON HOME AND/OR BUSINESS

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Port Barre, State of Louisiana, that the Town of Port Barre Code of Ordinances be, and the same is hereby amended. This ordinance repeals and replaces any and all previously adopted ordinances regarding the display of 911 physical addresses on homes and/or businesses.

SECTION 1: PROPER DISPLAY OF ADDRESS

- A. Street/road/alley/highway address numbers must be clearly displayed so that the location can be identified easily from the street, road, alley and/or highway.
 - The official address number must be displayed on the front of a building or at the entrance to a building, which is most clearly visible from the street, road, alley or highway during both day and night.
 - 2. If a building is more than seventy-five (75) feet from any street, road, alley or highway, the address number shall be displayed at the end of the driveway or easement nearest the street, road, alley or highway, which provides access to the building.
 - 3. Numerals indicating the address number of a single-family dwelling must be at least three (3) inches in height and shall be posted and maintained so as to be legible from the street, road or highway.
 - 4. Numerals of multiple dwelling units and nonresidential buildings shall be at least six (6) inches in height and shall be placed on the front of the building facing the street, road, alley or highway, or on the end of the building nearest the street, road, alley or highway.
 - 5. Numerals must be of contrasting color to the background.
 - 6. Mobile home lots shall have sequential address numbers throughout the park. Each lot will have a separate address number assigned. The address number of each lot must be clearly displayed on the lot so as to be legible from the street, road, alley or highway.
- B. The Mayor or his representative will have the right to authorize and approve alternate methods of displaying home or business numbers, which meet the intent of this article when strict adherence to these standards cannot be reasonably met.

SECTION 2: PENALTIES

- A. Any person who fails to comply with any of the foregoing provisions, within sixty (60) days of the effective date of this ordinance and thereafter within thirty (30) days after being notified in writing to do so, shall be in violation of this ordinance.
 - 1. Any person found to be in violation of this Ordinance, shall be fined not more than \$50.00 for the first offense, and not more than \$100.00 for the second and all subsequent offenses.

BE IT FURTHER ORDAINED by the Board of Aldermen for the Town of Port Barre, Louisiana, duly convened in regular session on the 2^{nd} day of July, 2019, that the provisions of this ordinance are hereby declared to be severable, and if any provision, word, phrase, or clause of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect the validity of the remaining portions thereof.

BE IT FURTHER ORDAINED by the Board of Aldermen for the Town of Port Barre, Louisiana, duly convened in regular session on the 2nd day of July, 2019, that this Ordinance shall become effective immediately upon signature of the Mayor.

This Ordinance having been introduced on June 4, 2019, by Alderman Hardy, notice of public hearing having been published on June 9, 2019, said public hearing having been held, and the Ordinance read in parts and considered, on motion of Alderman Hardy and seconded by Alderman Barron to adopt the Ordinance, a record vote was taken and the following result was had:
