ORDINANCE NO. $\frac{1}{1}$ OF 1992

DOG LEASH LAW

STATE OF LOUISIANA

TOWN OF PORT BARRE

BE IT ORDAINED by the Mayor and Board of Alderman of the Town of Port Barre, Louisiana, Parish of St. Landry, is hereby authorized to have impounded any dog or other animal of the canine species found running at large within the corporate limits of the town.

PENALTY FOR ALLOWING DOGS RUNNING AT LARGE: DEFINITION

- (a) For each dog, or other animal of the canine species, found running at large within the corporate limits of the Town of Port Barre, the owner of such dogs, or other animal of the canine species, shall be fined up to THIRTY AND NO/100 (\$30.00) DOLLARS per head for such dog, or other animals of the canine species so found to be running at large. For each subsequent offense which occurs within a year of payment of fine or conviction of a previous offense, the owner may be fined up to ONE HUNDRED AND NO/100 (\$100.00) DOLLARS per head per dog, regardless of whether it is the same dog or not.
- (b) The term "running at large" is defined as the going upon public or private property by an amimal without the owner or person in charge thereof having direct physical control over such animal.

NOT ALLOWED IN PUBLIC PLACES

- (a) No dogs, whether licensed or unlicensed, shall be allowed in public places such as bus stations, hotels, theaters or other similar places unless on a suitable and dependable leash or chain. Dogs so found shall be impounded.
- (b) No dogs, whether licensed or unlicensed, shall be allowed in restaurants, grocery stores or other establishments selling groceries or staple goods. Dogs so found shall be impounded.

IMPOUNDMENT OF DOGS RUNNING AT LARGE; DURATION REDEMPTION; FEE

(a) Any dog or other animal of the canine species found running at large within the corporate limits of the town shall be impounded for a period of five (5) days. Bona fide owners may redeem their dog within the first five (5) days upon the payment of the sum of THIRTY AND NO/100 (\$30.00) DOLLARS. interested party may redeem the dog after five (5) days upon payment of TWENTY AND NO/100 (\$20.00) DOLLARS. After five (5) days from the dog's impoundment, it will be disposed of according to a licensed veterinarian's discretion. The owner may also be charged with boarding expenses for the animal and with reasonable veterinary fees for the treatment and/or destruction of the animal.
