

ORDINANCE NO. 2 OF 2021
AMENDING ORDINANCE NO 2, 2007, KEEPING OF LIVESTOCK
AND FOWL, SECTION I, AND ADDING "SECTION X"
PENALTIES FOR VIOLATION

SECTION I. Purpose. It shall be unlawful within the corporate limits of the Town of Port Barre for any person to keep or maintain or to permit to be kept or maintained, cattle, horses, mules, sheep, goats, pigs or other livestock or to keep and maintain or to permit to be kept and maintained, ducks, geese, turkeys or other types of fowl or to have or maintain in a stable, barnyard, house or other type of enclosure for the keeping of any of the animals referred to hereinabove, with the following exception:

- a) Chickens are allowed as follows: no more than ten (10) adult birds per property with no more than twenty (20) hatchlings up to six (6) weeks old, at which point they must be removed. Chickens must be contained within a secured fenced-in area with cover and/or placed within a chicken coup. Cannot be allowed to roam freely, otherwise considered "roaming at large."
- b) Property owner and/or tenant must do the following:
 - 1. Keep the area clean, sanitized and not allow unpleasant odors.
 - 2. Take measures to ensure poultry does not carry or spread pestilent diseases.
 - 3. Keep the noise level down as to not disturb neighbors which carries the same penalties as the Town of Port Barre "Disturbing the Peace/Disorderly Conduct Ordinance.
 - 4. Make sure the poultry is cared for in such a manner as to not violate the State's law of cruelty to animals as described in La. R.S. 14:102.1.

SECTION II. Notice to Remove: Whenever it comes to the attention of the Town that any nuisance as defined in this ordinance exists, a notice in writing shall be served upon the occupant of the land where the nuisance exists, or in case there is no such occupant, then upon the owner of the property or his agent, notifying them of the existence of the nuisance and requesting its removal within thirty (30) days.

SECTION III. Responsibility for Removal: Upon proper notice, the owner of the livestock and/or fowl and the owner or occupant of the private property on which the same is located, either or all of them, shall be responsible for its removal. In the event of removal and disposition by the Town, the owner, or occupant of the private property where same is located, shall be liable for the expenses incurred, if there are any.

SECTION IV. Notice Procedure: The Board of Aldermen or its designated agent shall give notice of removal to the owner or occupant of the private property where the livestock and/or fowl is located, at least thirty (30) days before the time of compliance. It shall constitute sufficient notice when a copy of the notice is sent by registered mail to the owner or occupant of the private property at his last known address.

SECTION V. Removal of Livestock and/or Fowl from Property by Town: If the violation described in the notice has not been remedied within the thirty (30) day period of compliance, the Town shall have the right to take possession of the livestock and/or fowl and remove it from the premises. It shall be unlawful for any person to interfere with, hinder, or refuse to allow such person or persons to enter upon private property for the purpose of removing livestock and/or fowl under the provisions of the Ordinance. Before such final action shall be taken the Board of Aldermen shall cause to be printed in a newspaper having a substantial circulation in the Town a public notice indicating the intent of the Town to cause the removal of said livestock and/or fowl from private property.
