The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Monday, February 3, 2020, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Hardy, Pickney, Abshire and Robin. Absent: Barron.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Robin, accepting the minutes of the Regular Meeting held on January 7, 2020, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Motion by Pickney, seconded by Hardy granting Chief Boudreaux permission to discipline his employees by placing them on suspension for 3 days without pay. Unanimous.

Mayor Ardoin called upon Supervisor of Public Works, Chad Mayer. Mr. Mayer rendered his monthly activities and work order report.

Mayor Ardoin called upon Parks & Recreation Director, Hannah Levet. Ms. Levet rendered her monthly report on activities.

Motion by Hardy, seconded by Robin accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including youth league activities, posting of the meeting minutes, blighted properties, and purchase of the Saizan Avenue and T-ball fields from the School Board.
