COUNCIL PROCEEDINGS

OCTOBER 1, 2019

REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, October 1, 2019, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Barron, Pickney, Abshire and Hardy. Absent: Robin.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Barron, accepting the minutes of the Regular Meeting held on September 3, 2019, and the Special Meeting held on September 30, 2019, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Motion by Hardy, seconded by Abshire adopting a Resolution Requesting Financial Assistance From the State of Louisiana Under the Fiscal Year 2019-2020 Local Government Assistance and Community Water Enrichment Fund Programs. Unanimous.

Motion by Pickney, seconded by Hardy appointing Mr. Leroy Andrus to the Board for St. Landry Parish Fire District No. 2, to replace Mr. Michael Savant.

Mayor Ardoin called upon Chief Deon Boudreaux who rendered his monthly report.

Mayor Ardoin called upon Chad Mayer, Supervisor of Public Works, who rendered his monthly report.

Mayor Ardoin called upon Ms. Hannah Levet, Parks and Recreation Director, who rendered her monthly report and gave an update on Youth League activities.

Motion by Abshire, seconded by Barron accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including lift station repairs, employee retirement, blighted/deeded property ownership, manhole on Saizan, the Fruit of the Loom building and future library funding. Mr. Richard LeBouef with St. Landry Parish Solid Waste was present and addressed the audience regarding proposed changes to trash pickup. Mr. Ken Marks, candidate for St. Landry Parish President, was present and addressed the audience.

Motion by Abshire, seconded by Pickney to adjourn. Unanimous.
