The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, March 3, 2020, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Barron and Robin. Absent: Hardy and Abshire.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Robin, accepting the minutes of the Regular Meeting held on February 3, 2020, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Motion by Robin, seconded by Pickney accepting the fiscal year 2018-2019 audit prepared by the accounting firm of Kolder, Slaven & Company. Unanimous.

Motion by Robin, seconded by Barron granting Mayor Ardoin permission to turn over unpaid traffic citations to a collection agency. Unanimous.

Motion by Pickney, seconded by Barron appointing Donald Robin as Mayor Pro-Tem for the year 2020. Unanimous.

Motion by Pickney, seconded by Robin adopting a Resolution approving the Municipal Water Pollution Report (MWPP) prepared by CENLA Environmental for the year 2019, and submit to DEQ. Unanimous.

Motion by Robin, seconded by Barron adopting a Resolution proclaiming the Month of April, 2020 as "Fair Housing Month" in the Town of Port Barre. Unanimous.

Motion by Pickney, seconded by Barron adopting a Resolution proclaiming the week of April 13-18, 2020 as "Community Development Week" in the Town of Port Barre. Unanimous.

Motion by Robin, seconded by Pickney condemning the property located at 713 Saizan Avenue in the Town of Port Barre, upon the recommendation of Building Code Inspection Services. Unanimous.

Motion by Barron, seconded by Robin condemning the property located at 719 Saizan Avenue in the Town of Port Barre, upon the recommendation of Building Code Inspection Services. Unanimous.

Motion by Pickney, seconded by Robin granting an extension of ninety (90) days to the owner of the property located at 183 Beauxis Drive, to have the home brought up to code, and to turn the water on for renovation purposes, upon the recommendation of Building Code Inspection Services. Unanimous.

Mayor Ardoin called upon Chief Boudreaux. Chief Boudreaux rendered his monthly report.

Mayor Ardoin called upon Supervisor of Public Works, Chad Mayer. Mr. Mayer rendered his monthly activities and work order report.

Mayor Ardoin called upon Parks & Recreation Director, Hannah Levet. Ms. Levet was not present. However, Mayor Ardoin rendered her monthly report on activities.

Motion by Pickney, seconded by Robin accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had.

Motion by Pickney, seconded by Robin to adjourn. Unanimous.
