COUNCIL PROCEEDINGS

AUGUST 6, 2024

REGULAR MEETING

The Mayor and Board of Aldermen/Alderswoman of the Town of Port Barre met in regular session in the town hall on Tuesday, August 6, 2024, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Robin, Hebert, S. Hardy, G. Hardy and Kimble. Absent: None.

The Mayor and Board of Aldermen/Alderswoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Robin, seconded by Hebert, accepting the minutes of the Regular Meeting held on July 2, 2024, and to dispense with the reading thereof. Unanimous.

Motion by Kimble, seconded by S. Hardy adopting the General Alimony millage rate of 5.130 mills for tax year 2024. Unanimous.

Mayor Ardoin called for discussion and action on adjusting the water rates back to the amounts recommended by LRWA. Council and audience discussion was had, and Mayor Ardoin called for a motion.

Motion by G. Hardy, seconded by S. Hardy to adjust the rates back to the amounts recommended by LRWA. Mayor Ardoin polled the council and the vote was as follows: G. Hardy - yea; S. Hardy - yea; Kimble - nay; Hebert; nay and Robin - nay. Motion failed.

Mayor Ardoin called upon Chief Deon Boudreaux. Assistant Chief Robert Hardy was in attendance on behalf of Chief Boudreaux and rendered the monthly report of Police Department activities.

Mayor Ardoin called upon Gregory Leger, Town Superintendent. Mr. Leger gave an update on public works activities.

Mayor Ardoin called upon Kyla Rivette, Parks & Recreation Director. Ms. Rivette gave an update on parks, recreation and youth league activities.

Motion by Robin, seconded by Kimble accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including the water rates and budget numbers, condemnations and demolitions, grass cutting and blighted property.

Motion by Robin, seconded by Kimble to adjourn. Unanimous.
