COUNCIL PROCEEDINGS

DECEMBER 4, 2024

REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Wednesday, December 4, 2024, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Robin, S. Hardy, Hebert, G. Hardy and Kimble. Absent: None.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by G. Hardy, seconded by S. Hardy, accepting the minutes of the Regular Meeting held on November 5, 2024, and to dispense with the reading thereof. Unanimous.

Motion by Kimble, seconded by Hebert setting the public meeting dates for the year 2025 as follows: Tuesday, January 7; February 4; March 4; April 1; May 6; June 3; July 1; August 5; September 2; October 7; November 4; December 2. Unanimous.

Motion by Robin, seconded by S. Hardy hiring Mr. Robert Janise as a full-time, post-certified police officer, upon the recommendation of Chief Boudreaux. Unanimous.

Mayor Ardoin called upon Mr. Quan Pickney with the PBHS 4-H Club regarding a Mardi Gras parade. Mr. Pickney stated their intentions and the Mayor and Council had no objection to same.

Mayor Ardoin called upon Chief Deon Boudreaux. Chief Boudreaux rendered the monthly report of Police Department activities.

Mayor Ardoin called upon Superintendent Gregory Leger, who gave an update on public works activities.


Mayor Ardoin called upon Parks and Recreation Director Kyla Rivette. Ms. Rivette was not in attendance. Mayor Ardoin gave a brief update on Parks, Recreation and Youth League activities.

Motion by S. Hardy, seconded by Robin accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including the water system upgrades, RV Park sewer and electrical upgrades, blighted properties and streets.

Motion by Hebert, seconded by S. Hardy to adjourn. Unanimous.
