COUNCIL PROCEEDINGS

FEBRUARY 4, 2025

REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, February 4, 2025, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: S. Hardy, Hebert, G. Hardy and Kimble. Absent: Robin.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Hebert, seconded by S. Hardy, accepting the minutes of the Regular Meeting held on January 7, 2025, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin called for the opening of bids on the following surplus vehicles:

(1) 2005 Ford Crown Vic, VIN 102601 - bidding starts at \$200. No bids received.

(1) 2005 Ford Crown Vic VIN 145424 - bidding starts at \$200. No bids received.

(1) 2008 Ford Crown Vic VIN 106183 - bidding starts at \$200. No bids received.

(1) 2014 Chevrolet Impala VIN 108285 - bidding starts at \$200. One bid received from Mr. Cheyenne Guillory in the amount of \$501.00. Motion by G. Hardy, seconded by Kimble to accept the bid of Mr. Guillory in the amount of \$501.00. Unanimous.

(1) 2014 Dodge Charger VIN 122702 - bidding starts at \$200. Two bids received as follows: Mr. Kurt Soileau - \$1,000.00; and Mr. Derek Fontenot - \$450.00. Motion by S. Hardy, seconded by G. Hardy to accept the bid of Mr. Soileau in the amount of \$1,000.00. Unanimous.

Mayor Ardoin called upon Chief Deon Boudreaux who rendered the monthly report of Police Department activities.

Mayor Ardoin called upon Superintendent Gregory Leger who gave an update on public works activities.

Mayor Ardoin called upon Parks and Recreation Director Kyla Rivette who gave an update on Youth League and Parks and Recreation activities.

Motion by Hebert, seconded by S. Hardy accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Council, then the audience. General discussion was had, including employee sick leave, Police Department Easter egg hunt, the snow and water issues and site upgrade project, sewer & other improvements at the RV Park, homeless people, mobile home on Teche Street and other unkept properties in town, littering in town, trespassing and junk cars.

Motion by Kimble, seconded by Sammy to adjourn. Unanimous.
