COUNCIL PROCEEDINGS

MARCH 2, 2021

REGULAR MEETING

A public hearing was held in the Town Hall from 5:30 p.m. to 6:00 p.m. to allow citizens to provide comments and opinions on the adoption of Ordinance No. 1 of 2021, Disturbing the Peace/Disorderly Conduct, and Ordinance No. 2 of 2021, Amending the Keeping of Livestock and Fowl Ordinance. The ordinances were read, a few citizens were present, and very few comments or opinions were expressed.

Mayor Ardoin closed the public hearing at 6:00 p.m. The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the Town Hall on Tuesday, March 2, 2021, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Abshire, Barron, Robin and Hardy.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by the Honorable Mayor, John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Robin, seconded by Abshire accepting the minutes of the February 2, 2021 and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting. He advised the council that he has not heard back from Entergy regarding the lease. Also advised that the Town will be receiving approximately 700 yards of crushed asphalt from the State, which can be used to fill in pot-holes in streets. Still waiting on demolition of mobile home on Live Oak Street.

Motion by Pickney, seconded by Barron adopting Ordinance No. 1 of 2021, Disturbing the Peace/Disorderly Conduct. Unanimous.

Mayor Ardoin called upon the council, then the audience. General discussion was had, including street repairs, gas leaks, personnel policy, mobile home located at Burghdoff's old store, retirement, ordinances on website, live internet feed of town meetings and the Beautification Committee.

Motion by Abshire, seconded by Hardy to adjourn. Unanimous.
