## REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, May 6, 2025, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Robin, Hebert, Kimble, S. Hardy and G. Hardy. Absent: None.
