## COUNCIL PROCEEDINGS

NOVEMBER 2, 2021

### REGULAR MEETING

A public hearing was held in the Town Hall from 5:45 p.m. to 6:00 p.m. to allow citizens to provide comments and opinions on the adoption of Ordinance No. 6 of 2021, Compensation of Town Clerk and Superintendent; Ordinance No. 7 of 2021, Possession of Marijuana; Ordinance No. 8 of 2021, Intent to Acquire Full Ownership of 122 W. Courtableau Drive; and Ordinance No. 9 of 2021, Water, Sewer and Gas Rates, Connections, Deposits, Delinquency, Etc. The ordinances were read, a few citizens were present, and no comments or opinions were expressed.

Mayor Ardoin closed the public hearing at 6:00 p.m. The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the Town Hall on Tuesday, November 2, 2021, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Robin and G. Hardy. Absent: Abshire and S. Hardy.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by the Honorable Mayor, John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Robin accepting the minutes of the October 5, 2021 meeting, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Motion by Pickney, seconded by G. Hardy adopting Ordinance No. 6 of 2021, Compensation of Town Clerk and Superintendent. Unanimous.

Motion by Robin, seconded by G. Hardy adopting Ordinance No. 7 of 2021, Possession of Marijuana. Unanimous.

Motion by Pickney, seconded by Robin adopting Ordinance No. 8 of 2021, Intent to Acquire Full Ownership of 122 W. Courtableau Drive. Unanimous.

Motion by Robin, seconded by Pickney adopting Ordinance No. 9 of 2021, Water, Sewer and Gas Rates, Connections, Deposits, Delinquency, Etc. Unanimous.

Motion by Robin, seconded by G. Hardy condemning the property located at 156 Martin Luther King Drive. Unanimous.


Mayor Ardoin called upon Chief Boudreaux. Chief Boudreaux was not present, but the council was given the monthly report of activities of the Police Department.

Mayor Ardoin called upon Superintendent Greg Leger, who gave an update on public works activities.

Motion by Robin, seconded by Pickney accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had including the boil advisory and notification to the customers, water sector grants, toys for tots drive, Knights of Columbus coat drive, street improvements and street signs.

Motion by Pickney, seconded by Robin to adjourn. Unanimous.
