The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, November 4, 2025, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Hebert, Robin, S. Hardy and G. Hardy. Absent: Kimble.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Hebert, seconded by Robin, accepting the minutes of the Regular Meetings held on October 7, 2025, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin called upon Chief Boudreaux. Assistant Chief Robert Hardy was in attendance on behalf of the Chief, and rendered the monthly report of Police Department activities.

Mayor Ardoin called upon Superintendent Greg Leger who gave an update on public works activities.

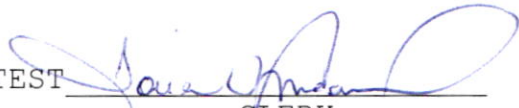
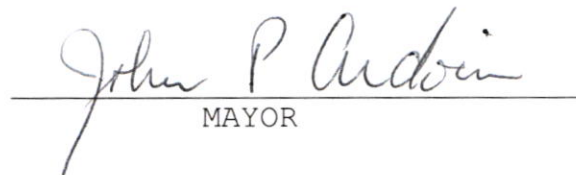
Mayor Ardoin called upon Parks and Recreation Director Kyla Rivette. Ms. Rivette was not present. Mayor Ardoin gave an update on Youth League activities, and advised that the flag football season had started.

Motion by S. Hardy, seconded by G. Hardy accepting all financial and departmental reports. Before the vote, Alderman Greg Hardy did have a question regarding the billing of Waterworks District No. 3 on the financials. He was advised that their billing is included with the total water charges to customers on the financial statement. Thereafter, the vote was unanimous.

Mayor Ardoin called upon the Council, then the audience. General discussion was had, including the water well site upgrades, cleaning of storm drains along Saizan Avenue, the possibility of closing some streets in town to vehicle traffic during Trick or Treat, blighted property and the Town's Christmas parade to be held in December. The President and Vice President of Port Barre High School's FFA club were in attendance and addressed the Mayor and Council regarding a "food drive" for the needy and the placement of boxes at one of the municipal buildings. The Mayor and Council commended them and stated that they had no problem with their mission to help feed the needy.

Motion by Hebert, seconded by S. Hardy to adjourn. Unanimous.
