The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, October 1, 2024, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Robin, S. Hardy, Hebert and Kimble. Absent: G. Hardy.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Kimble, seconded by S. Hardy, accepting the minutes of the Regular Meeting held on September 3, 2024, and the Special Meeting held on September 30, 2024, and to dispense with the reading thereof. Unanimous.

Motion by Hebert, seconded by S. Hardy granting permission to Mayor Ardoin to enroll all town employees into the Municipal Employees Retirement System (MERS). Unanimous.

Motion by S. Hardy, seconded by Kimble granting permission to Mayor Ardoin to advertise for bids to sell the following surplus vehicles: 2005 Ford Crown Vic, VIN 102601; 2005 Ford Crown Vic VIN 145424; 2008 Ford Crown Vic VIN 106183; 2014 Chevrolet Impala VIN 108285; 2014 Dodge Charger VIN 122702. Unanimous.

Motion by Hebert, seconded by S. Hardy granting permission to Mayor Ardoin to advertise for bids to demolish the following condemned properties: 223 Beauxis Drive; 129 Josie Street; 133 Josie Street. Unanimous.

Mayor Ardoin called upon Chief Boudreaux who rendered the monthly report of Police Department activities.

Mayor Ardoin called upon Gregory Leger, Town Superintendent, who gave an update on public works activities.


Mayor Ardoin called upon Kyla Rivette, Parks & Recreation Director, who gave an update on parks, recreation and youth league activities.
